	Roger open the public hearing with a little background, saying that it had been drawn to his attention that some construction and changes were being made outside at the Smyrna Tavern. Roger wrote a letter to the owners of the Smyrna Tavern; Marcus and Jennifer Bosch, informing them that permits were required for any exterior changes that they wanted to make to the property. An application was submitted for some of the exterior changes. It was noted that some structures had already been built on the property without a permit.
	The floor was open for public comment; a number of audience participants made statements, mostly supporting the presence of the bar in Smyrna. A few question the possibility of excess noise from live music, or bright lights from proposed outdoor entertainment. The State of Michigan's noise law will be enforced. Public comment was closed at 7:28 PM.

	After further discussion among the ZBA board members and the Zoning Board of Appeals administrator; it was agreed that the property should probably be surveyed first, and that it should go to the Planning Commission and receive a Special Use Permit before coming to the ZBA Board for any possible variances that need to be granted.
